4. PURPOSE OF THIS REQUEST FOR PROPOSAL (RFP)

Denel are looking for experienced service provider to Supply, Install commission of HFO Storage tank and delivery of heavy fuel oil (HFO) as and when required for period of 36 months.

This HFO is used to fuel the boiler house which serves the purpose of supplying the hot water to Denel Aeronautics production.

5. LEGISLATIVE FRAMEWORK OF THE BID

6. Tax Legislation

6.1.1 Bidder(s) must be compliant when submitting a proposal to Denel SOC Ltd and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).

6.1.2 It is a condition of this bid that the tax matters of the successful bidder be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder's tax obligations.

6.1.3 The Tax Compliance status requirements are also applicable to foreign bidders / individuals who wish to submit bids.

6.1.4 It is a requirement that bidders grant a written confirmation when submitting this bid that SARS may on an ongoing basis during the tenure of the contract disclose the bidder's

tax compliance status and by submitting this bid such confirmation is deemed to have been granted.

6.1.5 Bidders are required to be registered on the Central Supplier Database and the National Treasury shall verify the bidder's tax compliance status through the Central Supplier Database.

6.1.6 Where Consortia / Joint Ventures / Sub-contractors are involved, each party must be registered on the Central Supplier Database and their tax compliance status will be verified through the Central Supplier Database.

7. Procurement Legislation

- 11.3 Any communication to an official or a person acting in an advisory capacity for Denel SOC Ltd in respect of the bid between the closing date and the award of the bid by the Bidder(s) is discouraged.
- 11.4 All communication between the Bidder(s) and Denel SOC Ltd must be done in writing.
- 11.5 Whilst all due care has been taken in connection with the preparation of this bid, Denel SOC Ltd makes no representations or warranties that the content of the bid or any information communicated to or provided to Bidder(s) during the bidding process is, or will be, accurate, current or complete. Denel SOC Ltd, and its employees and advisors will not be liable with respect to any information communicated which may not accurate, current or complete.
- 11.6 If Bidder(s) finds or reasonably believes it has found any discrepancy, ambiguity, error or inconsistency in this bid or any other information provided by Denel SOC Ltd (other than minor clerical matters), the Bidder(s) must promptly notify Denel SOC Ltd in writing of

such discrepancy, ambiguity, error or inconsistency in order to afford Denel SOC Ltd an opportunity to consider what corrective action is necessary (if any).

11.7 Any actual discrepancy, ambiguity, error or inconsistency in the bid or any other information provided by Denel SOC Ltd will, if possible, be corrected and provided to all Bidder(s) without attribution to the Bidder(s) who provided the written notice.

13. COUNTER CONDITIONS

Bidders' attention is drawn to the fact that amendments to any of the Bid Conditions or setting of counter conditions by Bidders or qualifying any Bid Conditions will result in the invalidation of such bids.

14. FRONTING

14.1 Government supports the spirit of broad based black economic empowerment and recognizes that real empowerment can only be achieved through individuals and businesses conducting themselves in accordance with the Constitution and in an honest, fair, equitable, transparent and legally compliant manner. Against this background the Government condemn any form of fronting.

14.2 The Government, in ensuring that Bidders conduct themselves in an honest manner will, as part of the bid evaluation processes, conduct or initiate the necessary enquiries/investigations to determine the accuracy of the representation made in bid documents. Should any of the fronting indicators as contained in the Guidelines on Complex Structures and Transactions and Fronting, issued by the Department of Trade and Industry, be established during such enquiry / investigation, the onus will be on the Bidder / contractor to prove that fronting does not exist. Failure to do so within a period of 14 days from date of notification may invalidate the bid / contract and may also result in the restriction of the Bidder /contractor to conduct business with the public sector for a period not exceeding ten years, in addition to any other remedies Denel SOC Ltd may have against the Bidder / contractor concerned.

- 16.2 Bid documents will only be considered if received by Denel SOC Ltd before the closing date and time, regardless of the method used to send or deliver such documents to Denel SOC Ltd.
- 16.3 The bidder(s) are required to submit Two (2) copies of each file (one (1) original and one (1) duplicate) as a CD-ROM or Memory Stick with content of each file by the 17 March 2020 at 12:00. - 16.4 Bidders are requested to initial each page of the tender document on the top right hand corner.

17. PRESENTATION / DEMONSTRATION

Denel SOC Ltd reserves the right to request presentations/demonstrations from the short-listed Bidders as part of the bid evaluation process.

18. DURATION OF THE CONTRACT

The successful bidder will be appointed for a period of 36 (thirty six) months with an option to renew in Denel SOC Ltd sole discretion for an additional 24 (twenty four) months on the same terms and conditions unless the parties agree otherwise. The renewal of the contract will be at intervals of 12 (twelve) months each.

19. GENERAL CONDITIONS OF SPECIFICATION

- 19.1 The contractor shall ensure to attend a site inspection meeting; the date and time will be provided by the supply chain department.
- 19.2 An official site inspection form will be issued with every Tender Enquiry which must be duly completed, and submitted with the Tender as the first page of the Tender Document.
- 19.3 The contractor shall ensure to complete the Contractor Agreement form in conjunction with the Denel Industrial Properties supply chain, before commencing with the work.
- 19.4 The contractor must note that the only communication channel on all aspects of the work is via Denel Industrial Properties Project Leader.
- 19.5 The contractor will be responsible to execute the work to confirm to all the relevant S.A.B.S standards, Occupational Health and Safety Act No. 85 of 1993 and local Municipal laws and by – laws.
- 19.6 The successful tenderer shall upon notification in writing accompanied by an official order number, of the acceptance of his tender, immediately commence work.
- 19.7 No payment on satisfactory completion of the work will be affected unless an invoice is submitted to the Project Leader, on which the order number and other details are filled in.
- 19.8 No variation to the original order shall be allowed or undertaken unless so instructed, by an official variation order issued by the supply chain Department, implemented by the Project Leader. If any variation or modification is done without an official order, the costs of such modifications shall be for the contractor's own account and no claim whatsoever will be settled by Denel Industrial Properties.
- 19.9 Where material is specified in terms of make or catalogue numbers, no alternatives will be accepted. The phrase "Similar and equal to _____" requires that the equipment or material offered matches the specified equipment in appearance and that its character is equal to or better than those of the specified equipment. Tenders in whom equipment inferior to that specified is offered will be disqualified.

- 19.10 A tool inventory must be filled in and cleared by Security before any tools can be brought on site.
- 19.11 Validity of the quotation, delivery times, warranty / guarantee periods, conditions of payments, and all exclusions shall be clearly stipulated.
- 19.12 The contractor shall exercise due care in the performance of its duties and shall be liable for all costs or repair, replacement or otherwise of damage to the property, fixtures, fittings, finishes of equipment of Denel Industrial Properties or any third party. The contractor shall arrange and throughout the period of this project maintain at its own cost public liability insurance with a limit of indemnity of not less than R 5 000 000-00 for any one incident. Proof of liability cover shall be provided as part of the quotation.
- 19.13 Denel Properties shall be entitled to recover from the contractor loss or damage suffered by Denel Industrial Properties or any third party as a consequence of the breach by the contractor of any term of the general conditions of this specification or as a result of a negligent or wilful act or omission of the contractor or its employees or subcontractors acting within the course and scope of their employment with the contractor.
- 19.14 The contractor will be required to submit a safety file as per the safety manager's index or recommendations when contracted.

20.3 **ADDITIONAL REQUIREMENTS:**

- 20.3.1 The supplier shall be responsible maintenance of the installed infrastructure on a planned schedule and it must be submitted to Denel for approval
- 20.3.2 All unplanned maintenance shall be facilitated by the supplier at no cost to Denel.
- 20.3.3 Contractor / Supplier must be fast and effective to any problem arising on site without any delays
- 20.3.4 Contractor / supplier must adhere to our road and safety rules when driving on site.
- 20.3.5 The supplier will be held liable for any spillage they caused / created on site, and after disposal we will need a disposal certificate for our own record keeping environmental audits.

21. RIGHTS AND DUTIES OF THE SUPPLIER

- 21.1 The Supplier will provide the Customer (Denel Industrial Properties DIP) (with copies of material safety data sheets (As contemplated by Applicable Laws) and sufficient information to enable the customer to take the necessary measures regarding the protection of safety, health and the Environment.
- 21.2 The Supplier may require and specify minimum requirements for the Customer (Denel Industrial Properties DIP) to develop and implement safety, health and environmental management plans and systems and the Supplier will provide the Customer (Denel Industrial Properties DIP) with sufficient details of such requirements in writing and the extent to which such requirements are to be followed and/or implemented.
- 21.3 In addition to SHE Policies, the Supplier may from time to time impose other specific safety, health and environmental requirements to be adhered to by the Customer (Denel Industrial Properties DIP) to mitigate the risk of an incident(s) and for purposes of enhancing safety, health and environmental performance and the Supplier will provide the Customer with sufficient details of such requirements in writing and the extent to which such requirements are to be followed and/or implemented.

21.4 The Supplier may at any time undertake, or engage any Person to act on its behalf in order to undertake an audit of the processes and work implemented by the Customer in relation to the collection, storage, supply and/or sale (as the case may be) of the Product to ensure that the Customer is compliant with Applicable Laws and SHE Policies. For these purposes, the Customer will provide the Supplier and /or any Person action on its behalf, unrestricted and immediate access to the Premises.

22. EVALUATION AND SELECTION CRITERIA

- 25.4 Denel SOC Ltd reserves the right to accept or reject any or all amendments or additions proposed by a bidder if such amendments or additions are unacceptable to Denel SOC Ltd or pose a risk to the organisation.

26. SPECIAL CONDITIONS OF THIS BID

Denel SOC Ltd reserves the right:

- 26.2 To negotiate with one or more preferred bidder(s) identified in the evaluation process, regarding any terms and conditions, including price without offering the same opportunity to any other bidder(s) who has not been awarded the status of the preferred bidder(s).
- 26.3 To accept part of a tender rather than the whole tender.
- 26.4 To carry out site inspections, product evaluations or explanatory meetings in order to verify the nature and quality of the services offered by the bidder(s), whether before or after adjudication of the Bid.
- 26.5 To correct any mistakes at any stage of the tender that may have been in the Bid documents or occurred at any stage of the tender process.
- 26.6 To cancel and/or terminate the tender process at any stage, including after the Closing Date and/or after presentations have been made, and/or after tenders have been evaluated and/or after the preferred bidder(s) have been notified of their status as such.

 - g. To conduct their business activities with transparency and consistently uphold the interests and needs of Denel SOC Ltd as a client before any other consideration; and
 - h. To ensure that any information acquired by the bidder(s) from Denel SOC Ltd will not be used or disclosed unless the written consent of the client has been obtained to do so.

28. CONFLICT OF INTEREST, CORRUPTION AND FRAUD

- 28.1 Denel SOC Ltd reserves its right to disqualify any bidder who either itself or any of whose members (save for such members who hold a minority interest in the bidder through shares listed on any recognised stock exchange), indirect members (being any person or entity who indirectly holds at least a 15% interest in the bidder other than in the context of shares listed on a recognised stock exchange), directors or members of senior management, whether in respect of [Institution name] or any other government organ or entity and whether from the Republic of South Africa or otherwise ("Government Entity")
- a. engages in any collusive tendering, anti-competitive conduct, or any other similar conduct, including but not limited to any collusion with any other bidder in respect of the subject matter of this bid;
 - b. seeks any assistance, other than assistance officially provided by a Government Entity, from any employee, advisor or other representative of a Government Entity in order to obtain any unlawful advantage in relation to procurement or services provided or to be provided to a Government Entity;
 - c. makes or offers any gift, gratuity, anything of value or other inducement, whether lawful or unlawful, to any of Denel SOC Ltd's officers, directors, employees, advisors or other representatives;

32. PRECEDENCE

This document will prevail over any information provided during any briefing session whether oral or written, unless such written information provided, expressly amends this document by reference.

34. TAX COMPLIANCE

No tender shall be awarded to a bidder who is not tax compliant. Denel SOC Ltd reserves the right to withdraw an award made, or cancel a contract concluded with a successful bidder in the event that it is established that such bidder was in fact not tax compliant at the time of the award, or has submitted a fraudulent Tax Clearance Certificate to Denel SOC Ltd, or whose verification against the Central Supplier Database (CSD) proves non-compliant. Denel SOC Ltd further reserves the right to cancel a contract with a successful bidder in the event that such bidder does not remain tax compliant for the full term of the contract.

35. TENDER DEFAULTERS AND RESTRICTED SUPPLIERS

No tender shall be awarded to a bidder whose name (or any of its members, directors, partners or trustees) appear on the Register of Tender Defaulters kept by National Treasury, or who have been placed on National Treasury's List of Restricted Suppliers. Denel SOC Ltd reserves the right to withdraw an award, or cancel a contract concluded with a Bidder should it be established, at any time, that a bidder has been blacklisted with National Treasury by another government institution.

36. GOVERNING LAW

South African law governs this bid and the bid response process. The bidder agrees to submit to the exclusive jurisdiction of the South African courts in any dispute of any kind that may arise out of or in connection with the subject matter of this bid, the bid itself and all processes associated with the bid.

37. RESPONSIBILITY FOR SUB-CONTRACTORS AND BIDDER'S PERSONNEL

40. AVAILABILITY OF FUNDS

Should funds no longer be available to pay for the execution of the responsibilities of this bid RFP TMC01/06/08/2018 the Denel SOC Ltd may terminate the Agreement at its own discretion or temporarily suspend all or part of the services by notice to the successful bidder who shall immediately make arrangements to stop the performance of the services and minimize further expenditure: Provided that the successful bidder shall thereupon be entitled to payment in full for the services delivered, up to the date of cancellation or suspension.
