3. PURPOSE OF THIS REQUEST FOR PROPOSAL (RFP)

4. Tax Legislation

4.1.1 Bidder(s) must be compliant when submitting a proposal to Denel SOC Ltd and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).

4.1.2 It is a condition of this bid that the tax matters of the successful bidder be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder's tax obligations.

4.1.3 The Tax Compliance status requirements are also applicable to foreign bidders / individuals who wish to submit bids.

- 4.1.4 It is a requirement that bidders grant a written confirmation when submitting this bid that SARS may on an ongoing basis during the tenure of the contract disclose the bidder's tax compliance status and by submitting this bid such confirmation is deemed to have been granted.
- 4.1.5 Bidders are required to be registered on the Central Supplier Database and the National Treasury shall verify the bidder's tax compliance status through the Central Supplier Database.

- 9.4 All communication between the Bidder(s) and Denel SOC Ltd must be done in writing.
- 9.5 Whilst all due care has been taken in connection with the preparation of this bid, Denel SOC Ltd makes no representations or warranties that the content of the bid or any information communicated to or provided to Bidder(s) during the bidding process is, or will be, accurate, current or complete. Denel SOC Ltd, and its employees and advisors will not be liable with respect to any information communicated which may not accurate, current or complete.
- 9.6 If Bidder(s) finds or reasonably believes it has found any discrepancy, ambiguity, error or inconsistency in this bid or any other information provided by Denel SOC Ltd (other

than minor clerical matters), the Bidder(s) must promptly notify Denel SOC Ltd in writing of such discrepancy, ambiguity, error or inconsistency in order to afford Denel SOC Ltd an opportunity to consider what corrective action is necessary (if any).

- 9.7 Any actual discrepancy, ambiguity, error or inconsistency in the bid or any other information provided by Denel SOC Ltd will, if possible, be corrected and provided to all Bidder(s) without attribution to the Bidder(s) who provided the written notice.

- 11.1 Bidders' attention is drawn to the fact that amendments to any of the Bid Conditions or setting of counter conditions by Bidders or qualifying any Bid Conditions will result in the invalidation of such bids.

12. FRONTING

- 12.1 Government supports the spirit of broad based black economic empowerment and recognizes that real empowerment can only be achieved through individuals and businesses conducting themselves in accordance with the Constitution and in an honest, fair, equitable, transparent and legally compliant manner. Against this background the Government condemn any form of fronting.
- 12.2 The Government, in ensuring that Bidders conduct themselves in an honest manner will, as part of the bid evaluation processes, conduct or initiate the necessary enquiries/investigations to determine the accuracy of the representation made in bid documents. 15. PRESENTATION / DEMONSTRATION

15.1 Denel SOC Ltd reserves the right to request presentations/demonstrations from the short-listed Bidders as part of the bid evaluation process.

16. DURATION OF THE CONTRACT

16.1 Three (3) years contract

17. GENERAL CONDITIONS OF SPECIFICATION

17.1 All intellectual proprietary rights emanating from this project will reside with Denel.

17.2 All reports and working paper files shall become the property of Denel.

17.3 The prospective service providers must submit an all-inclusive price and detailed cost breakdown schedule (the price must be VAT inclusive).

17.4 Travelling costs and time spent or incurred between the service provider offices and Denel or home and office the staff shall not be for the account of Denel

17.5 Payment will be strictly based on completed and approved deliverables and time spent and not only based on time spent at Denel.

17.6 The successful bidder will be expected to conduct themselves in a manner that will be seen as part of Denel.

17.7 The contractor shall ensure to attend a site inspection meeting; the date and time will be provided by the buying department.

- 17.8 An official site inspection form will be issued with every Tender Enquiry which must be duly completed, and submitted with the Tender as the first page of the Tender Document.
- 17.9 The contractor shall ensure to complete the Contractor Agreement form in conjunction with the Denel Industrial Properties Buyer, before commencing with the work.
- 17.10 The contractor must note that the only communication channel on all aspects of the work is via Denel Industrial Properties Project Leader.
- 17.11 The contractor will be responsible to execute the work to confirm to all the relevant S.A.B.S standards, Occupational Health and Safety Act No. 85 of 1993 and local Municipal laws and by – laws.
- 17.12 The successful tenderer shall upon notification in writing accompanied by an official order number, of the acceptance of his tender, immediately commence work.
- 17.13 No payment on satisfactory completion of the work will be affected unless an invoice is submitted to the Project Leader, on which the order number and other details are filled in.
- 17.14 No variation to the original order shall be allowed or undertaken unless so instructed, by an official variation order issued by the Buying Department, implemented by the Project Leader. If any variation or modification is done without an official order, the costs of such modifications shall be for the contractor's own account and no claim whatsoever will be settled by Denel Industrial Properties.
- 17.15 Where material is specified in terms of make or catalogue numbers, no alternatives will be accepted. The phrase "Similar and equal to _____" requires that the equipment or material offered matches the specified equipment in appearance and that its character is equal to or better than those of the specified equipment. Tenders in whom equipment inferior to that specified is offered will be disqualified.
- 17.16 A tool inventory must be filled in and cleared by Security before any tools can be brought on site.
- 17.17 Validity of the quotation, delivery times, warranty / guarantee periods, conditions of payments, and all exclusions shall be clearly stipulated.
- 17.18 The contractor shall exercise due care in the performance of its duties and shall be liable for all costs or repair, replacement or otherwise of damage to the property, fixtures, fittings, finishes of equipment of Denel Industrial Properties or any third party. The contractor shall arrange and throughout the period of this project maintain at its own cost public liability insurance with a limit of indemnity of not less than R 5 000 000-00 for any one incident.

17.19 Denel Properties shall be entitled to recover from the contractor loss or damage suffered by Denel Industrial Properties or any third party as a consequence of the breach by the contractor of any term of the general conditions of this specification or as a result of a negligent or wilful act or omission of the contractor or its employees or subcontractors acting within the course and scope of their employment with the contractor

18. SCOPE OF WORK

To inspect, service and load test all the lifting equipment inclusive of all requirements specified below:-

18.1 INSPECTIONS/LOAD TESTING

18.1.1 All lifting equipment/machinery shall be inspected and load Tested by Competent LIFTING MACHINERY INSPECTOR

18.1.2 The registered lifting machine inspector performing the inspection and load test shall record and sign for such inspection / load test in the logbook provided by Denel Industrial Properties for each lifting machine

18.1.3 The registered lifting machine inspector performing the inspection and load test shall complete and sign for each task recorded as per the Denel Industrial Properties works order (job ticket) for each lifting machine. The LIFTING MACHINERY INSPECTOR no of the inspecting technician must be stamped on our log books

18.1.4 The inspection and load test shall in all aspects comply with the Occupational Health and Safety Act Regulation 18 of The Driven Machinery Regulations.

18.1.5 Quotations shall be based on the Denel Industrial Properties maintenance programme (viz. March/April- Sep/Oct) inspections must be performed twice per year(six months apart) and load test once per year (one year apart) to ensure compliance

18.1.6 All defects identified during the load test and or inspection shall be recorded on the Denel Industrial Properties works order (Job Ticket) for action and repairs by Denel Industrial Properties employees. Quotations for the repairs will be forwarded to Denel

18.1.7 The supplier will be responsible for moving and carrying the weights around the campus for load testing.

18.1.8 Log books will be filled on site and are not allowed to be moved out of both campus
