Denel (SOC) Ltd is the largest manufacturer of defence equipment in South Africa and operates in the military aerospace and landward defence environment. Incorporated as a private company in 1992 in terms of the South African Companies Act (No 62 of 1973)

5. Tax Legislation

5.1.1 Bidder(s) must be compliant when submitting a proposal to Denel SOC Ltd and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).

5.1.2 It is a condition of this bid that the tax matters of the successful bidder be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder's tax obligations.

5.1.3 The Tax Compliance status requirements are also applicable to foreign bidders / individuals who wish to submit bids.

- 5.1.4 It is a requirement that bidders grant a written confirmation when submitting this bid that SARS may on an ongoing basis during the tenure of the contract disclose the bidder's tax compliance status and by submitting this bid such confirmation is deemed to have been granted.
- 5.1.5 Bidders are required to be registered on the Central Supplier Database and the National Treasury shall verify the bidder's tax compliance status through the Central Supplier Database.

- 10.4 All communication between the Bidder(s) and Denel SOC Ltd must be done in writing.
- 10.5 Whilst all due care has been taken in connection with the preparation of this bid, Denel SOC Ltd makes no representations or warranties that the content of the bid or any information communicated to or provided to Bidder(s) during the bidding process is, or will be, accurate, current or complete. Denel SOC Ltd, and its employees and advisors will not be liable with respect to any information communicated which may not accurate, current or complete.
- 10.6 If Bidder(s) finds or reasonably believes it has found any discrepancy, ambiguity, error or inconsistency in this bid or any other information provided by Denel SOC Ltd (other than minor clerical matters), the Bidder(s) must promptly notify Denel SOC Ltd in writing of such discrepancy, ambiguity, error or inconsistency in order to afford Denel SOC Ltd an opportunity to consider what corrective action is necessary (if any).

13. FRONTING

- 13.1 Government supports the spirit of broad based black economic empowerment and recognizes that real empowerment can only be achieved through individuals and businesses conducting themselves in accordance with the Constitution and in an honest, fair, equitable, transparent and legally compliant manner. Against this background the Government condemn any form of fronting.

18. GENERAL CONDITIONS OF SPECIFICATION

- 18.1 All intellectual proprietary rights emanating from this project will reside with Denel.
- 18.2 All reports and working paper files shall become the property of Denel.
- 18.3 The prospective service providers must submit an all-inclusive price and detailed cost breakdown schedule (the price must be VAT inclusive).
- 18.4 Travelling costs and time spent or incurred between the service provider offices and Denel or home and office the staff shall not be for the account of Denel
- 18.5 Payment will be strictly based on completed and approved deliverables and time spent and not only based on time spent at Denel.
- 18.6 The successful bidder will be expected to conduct themselves in a manner that will be seen as part of Denel.

19. SCOPE OF WORK

The purpose of this RFP is to obtain quotations from suitably qualified and experienced suppliers to:

- Maintain and upgrade the Denel group and its divisions' websites and web security features.
- Make the websites responsive and adapt to smartphones; and
- Provide a preview button prior to uploading material on the websites.
- Migrate from current service provider to new service provider (if need be) of the website hosting service for Denel group and its division's websites.
- Provide a Web Environment based on CMS (Content Management System) and administrator login panel for Denel personnel to access and effect changes before publishing to a live environment.
- A total of 12 Business Divisions websites need to be maintained:
 - Denel Aeronautics, Denel Aerostructures, Denel Dynamics, Denel Industrial Properties, Denel Land Systems, Denel Mechem, Denel Overberg Test Range, Denel PMP, Denel S3, Denel SOC Ltd, Denel Technical Academy, Denel Vehicle Systems
- Each website must be updated by its own dedicated administrator.
- All administrators are managed by a single main administrator at Denel Corporate office.
- Design and develop on a framework that provides full-featured web applications.
- The CMS must provide a secure layer both on the application as well as the servers upon which it is stored and provide protection against all known attacks and penetration vulnerabilities.
- Create a Responsive and Adaptive (Dynamic) Website that can be accessed by all types of devices including Notebooks, Personal Computers, Tablets and Smart Phones.
- Websites must be SEO (Search Engine Optimisation) compliant and have Google Analytics including Google AdWords on all Denel Websites and to include Meta information on all web Pages Created.

Administrator Functionalities:
