18.4 Travelling costs and time spent or incurred between the service provider offices and Denel or home and office the staff shall not be for the account of Denel

18.5 Payment will be strictly based on completed and approved deliverables and time spent and not only based on time spent at Denel.

1. INTRODUCTION

Services of an engineering consultancy/consultant/expert in the design, development and manufacturing of hulls/military vehicles and turrets with extensive knowledge of the capabilities, costing and procurement process as well as project management pertaining there to are required. The service provider is required to assess the capabilities of the entities and work identified, provide expert opinion and prepare a report that shall form part of evidence for a litigation, which must be urgently instituted.

The competency and expertise of bidder should be around Engineering manufacturing and Consulting, Legal expertise, Purchasing of Military equipment, and forensic investigation.

2. OBJECTIVES

- 2.1. To assess the capabilities of Denel's divisions to determine if the work the work listed in paragraph 2 could have been done internally;
- 2.2. To provide expert opinion regarding the decision to outsource the said work as well as alternative suppliers for the out-sourced work;
- 2.3. To assess the prices charged for the out-sourced work and give expert opinion regarding the fairness and competitiveness of the prices and whether Denel has suffered any loss as a result of the out-sourcing.
- 2.4. Quantify any losses Denel may have suffered as a result of the out sourcing
