3. PURPOSE OF THIS REQUEST FOR PROPOSAL (RFP)

Denel Corporate Office Denel is looking to appoint a service provider for the Garden and Land Services required by Denel Industrial Properties (Kempton Park Campus), Denel Land System and Denel Vehicle Systems.

4. LEGISLATIVE FRAMEWORK OF THE BID

5. Tax Legislation

- 5.1.1 Bidder(s) must be compliant when submitting a proposal to Denel SOC Ltd and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).
- 5.1.2 It is a condition of this bid that the tax matters of the successful bidder be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder's tax obligations.
- 5.1.3 The Tax Compliance status requirements are also applicable to foreign bidders / individuals who wish to submit bids.
- 5.1.4 It is a requirement that bidders grant a written confirmation when submitting this bid that SARS may on an ongoing basis during the tenure of the contract disclose the bidder's tax compliance status and by submitting this bid such confirmation is deemed to have been granted.
- 5.1.5 Bidders are required to be registered on the Central Supplier Database and the National Treasury shall verify the bidder's tax compliance status through the Central Supplier Database.
- 5.1.6 Where Consortia / Joint Ventures / Sub-contractors are involved, each party must be registered on the Central Supplier Database and their tax compliance status will be verified through the Central Supplier Database.

6. Procurement Legislation

Denel SOC Ltd has a detailed evaluation methodology premised on Treasury Regulation 16A3 promulgated under Section 76 of the Public Finance Management Act, 1999 (Act, No. 1 of 1999), the Preferential Procurement Policy Framework Act 2000 (Act, No.5 of 2000) and the Broad-Based Black Economic Empowerment Act, 2003 (Act, No. 53 of 2003).

7. Technical Legislation and/or Standards

- 10.3 Any communication to an official or a person acting in an advisory capacity for Denel SOC Ltd in respect of the bid between the closing date and the award of the bid by the Bidder(s) is discouraged.
- 10.4 All communication between the Bidder(s) and Denel SOC Ltd must be done in writing.
- 10.5 Whilst all due care has been taken in connection with the preparation of this bid, Denel SOC Ltd makes no representations or warranties that the content of the bid or any information communicated to or provided to Bidder(s) during the bidding process is, or will be, accurate, current or complete. Denel SOC Ltd, and its employees and advisors will not be liable with respect to any information communicated which may not accurate, current or complete.
- 10.6 If Bidder(s) finds or reasonably believes it has found any discrepancy, ambiguity, error or inconsistency in this bid or any other information provided by Denel SOC Ltd (other than minor clerical matters), the Bidder(s) must promptly notify Denel SOC Ltd in writing of such discrepancy, ambiguity, error or inconsistency in order to afford Denel SOC Ltd an opportunity to consider what corrective action is necessary (if any).

- 10.7 Any actual discrepancy, ambiguity, error or inconsistency in the bid or any other information provided by Denel SOC Ltd will, if possible, be corrected and provided to all Bidder(s) without attribution to the Bidder(s) who provided the written notice.
- 10.8 All persons (including Bidder(s)) obtaining or receiving the bid and any other information in connection with the Bid or the Tendering process must keep the contents of the Bid and other such information confidential, and not disclose or use the information except as required for the purpose of developing a proposal in response to this Bid.

11. LATE BIDS

- 11.1 Bids received after the closing date and time, at the address indicated in the bid documents, will not be accepted for consideration and where practicable, be returned unopened to the Bidder(s).

12. COUNTER CONDITIONS

- 12.1 Bidders' attention is drawn to the fact that amendments to any of the Bid Conditions or setting of counter conditions by Bidders or qualifying any Bid Conditions will result in the invalidation of such bids.

13. FRONTING

- 13.1 Government supports the spirit of broad based black economic empowerment and recognizes that real empowerment can only be achieved through individuals and businesses conducting themselves in accordance with the Constitution and in an honest, fair, equitable, transparent and legally compliant manner. Against this background the Government condemn any form of fronting.
- 13.2 The Government, in ensuring that Bidders conduct themselves in an honest manner will, as part of the bid evaluation processes, conduct or initiate the necessary enquiries/investigations to determine the accuracy of the representation made in bid documents. Should any of the fronting indicators as

contained in the Guidelines on Complex Structures and Transactions and Fronting, issued by the Department of Trade and Industry, be established during such enquiry / investigation, the onus will be on the Bidder / contractor to prove that fronting does not exist. 16. PRESENTATION / DEMONSTRATION

16.1 Denel SOC Ltd reserves the right to request presentations/demonstrations from the short-listed Bidders as part of the bid evaluation process.

17. DURATION OF THE CONTRACT

17.1 The successful bidder will be appointed for a period of 36 (3 years) months.

18. GENERAL CONDITIONS OF SPECIFICATION

18.1 All intellectual proprietary rights emanating from this project will reside with Denel.

18.2 All reports and working paper files shall become the property of Denel.

18.3 The prospective service providers must submit an all-inclusive price and detailed cost breakdown schedule (the price must be VAT inclusive).

18.4 Travelling costs and time spent or incurred between the service provider offices and Denel or home and office the staff shall not be for the account of Denel

18.5 Payment will be strictly based on completed and approved deliverables and time spent and not only based on time spent at Denel.

18.6 The successful bidder will be expected to conduct themselves in a manner that will be seen as part of Denel.

19. SCOPE OF WORK

1. Introduction

Denel is a state-owned company governed in terms of the Companies Act as amended, the Public Finance Management Act and other relevant public sector laws and regulations.

Denel operates in a highly regulated and competitive global business environment in aerospace and defence which is characterized by long-term contracts, complex supply chain and inherent foreign exchange, project, financial, contracting, security, transportation, regulatory as well as design, manufacturing and other export risks.

Denel is comprised of:

- Corporate Office, which is accountable to the Board and the Shareholder, the Department of Enterprises for the performance of the group and acts as an interface with the shareholder environment, government departments, investors and other stakeholders.
- Operating divisions and subsidiaries, which are accountable for design, development and manufacturing and execution of contracts and overall divisional performance.

Denel's operations are situated as follows: Denel PMP, Pretoria West; LMT, Waltloo; Denel Vehicle Systems, Benoni; Denel Land, Systems Lyttelton; Denel Dynamics, Irene; Denel Corporate Office, Irene and Denel Aeronautics, Kempton Park.

2.1 The Garden and Land Maintenance must be carried out in accordance with the Maintenance Schedule – Appendix A.

2.2 The areas in which the different tasks are to be undertaken, as well as the definitions of the tasks are described in the following paragraphs. Also refer to the site plan, Appendix B, for the classification of the priority areas.

3. TASK DEFINITIONS

3.1. LAWN AREA (HIGH PRIORITY)

3.1.1 MOWING

During the growing season all lawns will be cut at least once (1) per 14 days and the grass maintained at a height of 25mm. During the Dormant and Medium-Dormant (May, June, July, August and September) periods lawns will be cut as and when required to maintain an aesthetically standard. All grass cuttings shall be removed in priority areas.

3.1.2 EDGING

The grass shall be edged to its local confines (e.g. Around Trees, Lampposts, Sign boards, Manholes, Drains, Fences, walls, waste bins, pipe lines and against building) Mechanical Edge trimmers and or weed killing spray shall be used. All trimmings and or clipping shall be removed from sidewalks, driveways, taxiways, handstands and kerbings in priority areas.

Note: High Priority areas indicated as per site layout drawing attached.

3.2 GRASS AREA (Medium Priority)

3.2.1 MOWING

During the growing season all grass will be cut at least once every two week and the grass maintained at a height of 50mm. During the Dormant and Medium Dormant (May, June, July, August, September) periods grass will be cut as and when required to maintain an aesthetically acceptable standard. All grass cuttings shall be removed in medium-priority areas.

3.2.2 EDGING

The grass shall be edged to its local confines (e.g. Around Trees, Lampposts, Sign boards, Manholes, Drains, Fences, walls, waste bins, pipe lines and against buildings). Mechanical edge trimmers and or weed killing spray shall be used. All trimmings and or clippings shall be removed from sidewalks driveways, taxiways, hardstands and kerbings in medium priority areas.

Note: Medium-priority areas indicated as per site layout drawing attached.

3.3 Grass area (Low Priority)

3.3.1 Mowing

During the growing season all grass will be cut at least once every two weeks and the grass maintained at a height of 50mm. During the Dormant period (June, July and August) grass will be cut as and when required to maintain an aesthetically acceptable standard. Grass cuttings to be removed if they are a physical impediment to healthy grass growth or if they are aesthetically unacceptable.

3.3.2 EDGING

The grass shall be edged to its local confines (e.g. Around Trees, Lampposts, Sign boards, Manholes, Drains, Fences, walls, waste bins, pipe lines and against buildings). Mechanical edge trimmers and or weed killing spray shall be used. All trimmings and or clippings shall be removed from sidewalks driveways, taxiways, hardstands and kerbings in non-priority areas.

Note: Low priority area indicated as per site layout drawing attached.

3.4 WEED CONTROL

3.4.1 Lawn areas shall be kept reasonably weed free by the application of suitable herbicides (SANS Approved) or by hand weeding.

3.4.2 The Security Fence surrounding the factory area must be kept clean of grass and weed free at all-time using a total weed killer applied periodically as recommended by the supplier. Surplus grass and weed shall be removed.

3.4.3 Low-priority kerbing edges to be sprayed with weed killer to a width of 100mm.

3.4.4 All roads and sidewalks and areas against buildings to be kept weed free by spraying weed killer. Weeds control all around the parking area in all the divisions

Note: Weed Killing products will not be allowed unless SANS approved

3.5 GROUND COVER, SHRUBS AND FLOWER BEDS

Flower beds shall be kept weeded and free of debris, leaves and diseased plants and on a regular basis, so as to maintain a neat, crisp and clean appearance. Should soil become compacted to the extent that moisture penetration is affected, the soil crust be lightly forked or hoed without damaging the plants or plant roots.

3.5.1 Ground covers will be kept weeded and free of debris, leaves and diseased plants necessary to achieve an overall even appearance. Trimming where necessary around trees and shrubs shall be carried out as required.

3.5.2 Shrubs shall not be clipped into balled or boxed forms unless such is specifically required, but shall be pruned, trimmed and shaped regularly so as to encourage healthy growth patterns for each specific variety. All the above to be carried out to an accepted good Horticultural practice.

3.6 TREES (NEW)

Staking and guying of newly planted trees must be done using approved materials. Pruning shall be carried out on a regular basis and according to good tree care practice.

3.7 WATERING

3.7.1 Hand watering shall be the responsibility of the gardening contractor. All ornamental areas not covered by a sprinkling system must be watered by means of a water trailer which will be supplied by Denel SOC Ltd. (e.g. All Priority Areas).

3.7.2 The irrigation system shall be monitored and adjusted regularly, based on changes in rainfall and temperature. Any malfunction or defect of the system, shall be reported to by Denel SOC Ltd, immediately after detection by the contractor. Any repairs to the system and accessories thereto will be the responsibility of Denel SOC Ltd.

3.7.3 Damage done to the System by Gardening maintenance will be for the Contactors Account.

3.8 HARDSCAPE AREAS

3.8.1 Shall be cleaned of garden debris during normal maintenance operation. These areas will be inspected regularly for undesirable plant growth and if necessary a suitable approved herbicide will be applied.

3.8.2 All Car parks and Carports to be kept clean and weed free by applying a weed killer.

3.8.3 Hardstand (Aircraft Taxiways, and Run-up Area)

The Hardstand areas within the factory Boundaries are to be kept totally weed free by applying a weed killer.

3.9 FENCED-IN AREAS (EXCLUDING SECURITY FENCE-SEE ITEM 4.2)

All fenced in areas shall be maintained, specified as per item 8.1, by the Contractor. Substation Yards and Gas Installations are excluded and shall be the responsibility of tenants.

3.10 TREE FELLING (HIGH PRIORITY AREAS)

All dead trees to be removed by the Contractor, dumped in area provided – Additional cost to Client quote's requested.

3.12 BRAVO GATE DAM

Dam water-level to be controlled and maintained at Pre-determined level by means of borehole pumps where applicable. Reeds and undesirable plant growth shall be controlled to ensure a neat appearance.

3.13 HOSTEL FACILITY

Maintain all grass areas surrounding Hostel (Applicable in Kempton Park) with exclusion of lawns and beds adjacent to front and south side of Hostel Building.

3.3.3 PERIMETE FENCE (ELECTRIC FENCE)

The area between the perimeter fences shall be kept free of grass and weed at all times.

4. Health and Safety

4.1 Aspects with regard to compliance with Health and Safety legislation will be detailed in Contractual agreement concluded between Denel SOC LTD and the contactor.

5. Adhock Tasks

- Rubbish and debris to be removed from all areas within the Denel Divisions and be deposited to domestic skips.
- Empty the canteen and Configuration wheelie bins every day, and in all other areas across Denel SOC Ltd as when necessary.
- Wash and clean all wheelie bins once a week where applicable.

20. EVALUATION AND SELECTION CRITERIA

23.3 Bidder(s) are requested to:

- a. Comment on draft Service Level Indicators and where necessary, make proposals to the indicators;
- b. Explain each comment and/or amendment; and
- c. Use an easily identifiable colour font or “track changes” for all changes and/or amendments to the Service Level Indicators for ease of reference.

23.4 Denel SOC Ltd reserves the right to accept or reject any or all amendments or additions proposed by a bidder if such amendments or additions are unacceptable to Denel SOC Ltd or pose a risk to the organisation.

24. SPECIAL CONDITIONS OF THIS BID

- 24.1 Denel **SOC Ltd reserves the right:**
- 24.2 To award this tender to a bidder that did not score the highest total number of points, only in accordance with section 2(1)(f) of the PPPFA (Act 5 of 2000)
- 24.3 To negotiate with one or more preferred bidder(s) identified in the evaluation process, regarding any terms and conditions, including price without offering the same opportunity to any other bidder(s) who has not been awarded the status of the preferred bidder(s).
- 24.4 To accept part of a tender rather than the whole tender.
- 24.5 To carry out site inspections, product evaluations or explanatory meetings in order to verify the nature and quality of the services offered by the bidder(s), whether before or after adjudication of the Bid.
- 24.6 To correct any mistakes at any stage of the tender that may have been in the Bid documents or occurred at any stage of the tender process.

26. CONFLICT OF INTEREST, CORRUPTION AND FRAUD

26.1 Denel SOC Ltd reserves its right to disqualify any bidder who either itself or any of whose members (save for such members who hold a minority interest in the bidder through shares listed on any recognised stock exchange), indirect members (being any person or entity who indirectly holds at least a 15% interest in the bidder other than in the context of shares listed on a recognised stock exchange), directors or members of senior management, whether in respect of [Institution name] or any other government organ or entity and whether from the Republic of South Africa or otherwise ("Government Entity")

- a. engages in any collusive tendering, anti-competitive conduct, or any other similar conduct, including but not limited to any collusion with any other bidder in respect of the subject matter of this bid;
- b. seeks any assistance, other than assistance officially provided by a Government Entity, from any employee, advisor or other representative of a Government Entity in order to obtain any unlawful advantage in relation to procurement or services provided or to be provided to a Government Entity;

30. PRECEDENCE

30.1 This document will prevail over any information provided during any briefing session whether oral or written, unless such written information provided, expressly amends this document by reference.

31. LIMITATION OF LIABILITY

31.1 A bidder participates in this bid process entirely at its own risk and cost. Denel SOC Ltd shall not be liable to compensate a bidder on any grounds whatsoever for any costs incurred or any damages suffered as a result of the Bidder's participation in this Bid process.

32. TAX COMPLIANCE

32.1 No tender shall be awarded to a bidder who is not tax compliant. Denel SOC Ltd reserves the right to withdraw an award made, or cancel a contract concluded with a successful bidder in the event that it is established that such bidder was in fact not tax compliant at the time of the award, or has submitted a fraudulent Tax Clearance Certificate to Denel SOC Ltd, or whose verification against the Central Supplier Database (CSD) proves non-compliant. Denel SOC Ltd further reserves the right to cancel a contract with a successful bidder in the event that such bidder does not remain tax compliant for the full term of the contract.

33. TENDER DEFAULTERS AND RESTRICTED SUPPLIERS

33.1 No tender shall be awarded to a bidder whose names (or any of its members, directors, partners or trustees) appear on the Register of Tender Defaulters kept by National Treasury, or who have been placed on National Treasury's List of Restricted Suppliers. Denel SOC Ltd reserves the right to withdraw an award, or cancel a contract concluded with a Bidder should it be established, at any time, that a bidder has been blacklisted with National Treasury by another government institution.

34. GOVERNING LAW

34.1 South African law governs this bid and the bid response process. The bidder agrees to submit to the exclusive jurisdiction of the South African courts in any dispute of any kind that may arise out of or in connection with the subject matter of this bid, the bid itself and all processes associated with the bid.

35. RESPONSIBILITY FOR SUB-CONTRACTORS AND BIDDER'S PERSONNEL

35.1 A bidder is responsible for ensuring that its personnel (including agents, officers, directors, employees, advisors and other representatives), its sub-contractors (if any) and personnel of its sub-contractors comply with all terms

and conditions of this bid. In the event that Denel SOC Ltd allows a bidder to make use of sub-contractors, such sub-contractors will at all times remain the responsibility of the bidder and Denel SOC Ltd will not under any circumstances be liable for any losses or damages incurred by or caused by such sub-contractors.

36. CONFIDENTIALITY

- 36.1 Except as may be required by operation of law, by a court or by a regulatory authority having appropriate jurisdiction, no information contained in or relating to this bid or a bidder's tender(s) will be disclosed by any bidder or other person not officially involved with Denel SOC Ltd's examination and evaluation of a Tender.
- 36.2 No part of the bid may be distributed, reproduced, stored or transmitted, in any form or by any means, electronic, photocopying, recording or otherwise, in whole or in part except for the purpose of preparing a Tender. This bid and any other documents supplied by Denel SOC Ltd remain proprietary to Denel SOC Ltd and must be promptly returned to Denel SOC Ltd upon request together with all copies, electronic versions, excerpts or summaries thereof or work derived there from.
- 36.3 Throughout this bid process and thereafter, bidder(s) must secure Denel SOC Ltd.'s written approval prior to the release of any information that pertains to (i) the potential work or activities to which this bid relates; or (ii) the process which follows this bid. Failure to adhere to this requirement may result in disqualification from the bid process and civil action.

37. DENEL SOC LTD PROPRIETARY INFORMATION

- 37.1 Bidder will on their bid cover letter make declaration that they did not have access to any Denel SOC Ltd proprietary information or any other matter that may have unfairly placed that bidder in a preferential position in relation to any of the other bidder(s).

38. AVAILABILITY OF FUNDS

38.1 Should funds no longer be available to pay for the execution of the responsibilities of this bid RFP DEN415/28/02/2019 the Denel SOC Ltd may terminate the Agreement at its own discretion or temporarily suspend all or part of the services by notice to the successful bidder who shall immediately make arrangements to stop the performance of the services and minimize further expenditure: Provided that the successful bidder shall thereupon be entitled to payment in full for the services delivered, up to the date of cancellation or suspension.
